

1. ORGANIZER AND DURATION

- 1) The organizer of the Promotional Campaign „3+1 promotion" is: NaiLac S.C. Sylwia and Urszula Pfajfer, based at Senatorska 50/58-62, 92-193 Łódź , NIP: 7252155065, owner of the brand NaiLac hereinafter referred to as "NaiLac brand".
- 1) The Promotion will last from 08.03.2024, 9:00 AM – 10.03.2024, 11:59 PM.

2. TERMS OF PARTICIPATION

In the Promotion may participate any Client who:

- 1) places an order at the NaiLac brand online store (www.NaiLac.pl) for a minimum of four products from the same product category in the same capacity during the Promotion period.
- 2) During the Promotion will place an order by phone (+48 575 50 70 85) for four products from the same category.
- 3) When ordering products from the "Hybrid Bases", „Hybrid Tops", „JellyMe!", „Jelly Bottle" categories, will purchase a maximum of 8 products of the same capacity and 6 the same products from the „OpalX" categorie.

3. TERMS AND CONDITIONS OF THE PROMOTION

- 1) Only orders placed from 08.03.2024, 9:00 AM – 10.03.2024, 11:59 PM will be covered by the Promotion.
- 2) During the Promotion, a Client buying four products of the same category and capacity will get the fourth cheapest one for 1 PLN.
- 3) The following items/categories are covered by the Promotion:
 - nail polishes (including hybrid nail polishes, rubber nail polishes, hybrid bases and tops)
 - Champagne
 - Glow Base
 - Glammy Base
 - JellyMe – gel in the bottle,
 - Jelly Bottle,
 - TiX-Jelly,
 - Builder Jelly Gels,

 - liquid preparations,

When placing an order by phone (+48 575 50 70 85) please inform the Customer Advisor that you would like to use the "3+1" promotion.
- 8) The Organiser reserves the right to shorten the Promotion duration or to exclude items from the Promotion as a result of running out of stock. The Organiser also reserves the right to exclude or change the payment method during the Promotion
(e.g. excluding the possibility of payment via the Przelewy24 Internet payment system).
- 9) Products purchased in the "3+1" Promotion are not exchangeable. In accordance with the Act on Protection of Consumer Rights the products included in the Promotion may be returned within 14 days from the date of purchase. The whole order, i.e. three purchased products and the fourth being a gift, may be returned.

4. FINAL PROVISIONS

- 1) Any information on the Promotion 3+1 contained in any promotional and advertising materials shall be of an additional character only. Binding information are the provisions of the Regulations.
